Jelena Galić, Predsednica Izvršnog odbora AIK Banke, svoju profesionalnu karijeru započinje na Ekonomskom institutu, aktivno učestvujući u razvoju ključnih nacionalnih strategija kroz projekte vezane za upravljanje ekonomskom politikom i sprovođenje strukturnih reformi u finansijskom sektoru. Svojim trudom, znanjem i zalaganjem g-đa Galić ubrzo postaje Izvršni direktor Ekonomskog insituta i na toj poziciji ostaje narednih šest godina. Karijerni put nastavlja u kompaniji Deloitte Beograd (Deloitte CE) kao generalni direktor za poslovno savetovanje odgovorna za konsalting finansijskih institucija u cilju poboljšanja poslovanja za region Centralne Evrope.

Sa više od 20 godina iskustva u bankarstvu na ključnim pozicijama, g-đa Galić je uporedo sticala značajnu akademsku i stručnu ekspertizu u oblasti finansija i bankarstva, ne samo na strateškom, već i na operativnom nivou. Diplomom osnovnih studija, potom zvanje Magistra i doktora nauka stekla je na Ekonomskom Fakultetu u Beogradu. Učestvovala je na brojnim domaćim i međunarodnim konferencijama i objavila više od 40 naučnih radova o monetarnoj politici i stabilnosti bankarskog sektora. Stečeno znanje ali i dragoceno iskustvo nesebično prenosi na mlade generacije kao vanredni profesor na Beogradskoj bankarskoj akademiji.

Chair of the Executive Board at AIK Banka

Jelena Galić, Chair of the Executive Board at AIK Banka, began her career at the Economics Institute through active participation in the development of key national strategies via projects aimed at economic policy management and the implementation of structured reforms within the financial sector. Her hard work, expertise and commitment quickly led her to becoming the Economic Institutes' Executive Director, a position she would hold for the following 6-year period. Her career path continues at Deloitte Belgrade (Deloitte CE) as Director of Business Advisory Services, at which time she was responsible for the provision of consulting services to financial institutions, the aim being to enhance business operations throughout the Central European region.

In 2015 she is appointed Chair of the Executive Board at AIK Banka, a position she holds to this day. Three years subsequently she is also named Chair of the Supervisory Board at Gorenjska Banka d.d. Kranj.

Under her leadership, AIK Banka has continued to improve its operations and strengthen its position both in the local, as well as the regional market. This is achieved through the acquisition of Alpha Bank in Serbia and Gorenjske Banka in Slovenia whereby AIK Banka becomes a regional banking group with assets amounting to approximately EUR 4 billion and the only domestic bank to penetrate the EU market.

With over 20 years' experience in top management within the banking industry, Ms Galić has also gained academic, financial and banking expertise, not only at the strategic but also at the operational level. She completed a Bachelor's degree at the Faculty of Economics in Belgrade, where she continued on to earn a Master's Degree and subsequently a PhD. She has participated in numerous domestic and international conferences and has published over 40 scientific papers on the subject of monetary policy and banking sector stability. She selflessly passes on her knowledge and invaluable experience to younger generations through her role as Associate Professor at the Belgrade Banking Academy.

She is a founder of the Serbian Association of Managers and is an active member of the Board of Directors at the Association of Serbian Banks, Banking Committee of the Serbian Chamber of Commerce, Serbian Association of Corporate Directors, Academic Society of Serbian Economists and the Business Club *Privrednik*.

She was named Best Banking CEO of the Year Eastern Europe 2020 by the renowned financial magazine *International Banker* and received the Kapetan Miša Anastasijević award for Businesswoman of the Year 2015.
