Na poziciju člana Izvršnog odbora AIK Banke imenovan je jula 2018. godine. Odgovoran je za uspostavljanje sistema regulatornog izveštavanja, kao i uspostavljanje OPEN API infrastrukture i transfer svih servisa, digitalizaciju i uvođenje online proizvoda Banke.

Svoju karijeru započeo je Narodnoj Banci Srbije, gde je tokom 10 godina učestvovao u izradi važnih zakona u oblasti bankarskih usluga i finansijskog poslovanja, između ostalih i Zakona o bankama. Značajno je doprineo razvoju i realizaciji projekta uvođenja nacionalne kartice DinaCard, uspostavljanju sistema zaštite korisnika usluga kao i mnogim drugim projektima od značaja za razvoj bankarskog sistema.

Karijeru nastavlja u KfW-u Frankfurt, na projektu Razvojne banke, a zatim u Vojvodjanskoj banci 2012. godine kao direktor Sektora za podršku poslovima sa privredom i stanovništvom, a kasnije i direktor Sektora pravnih poslova. U AIK banku prelazi sa pozicije člana Izvršnog odbora, nadležan za upravljanje problematičnim plasmanima, pravne poslove i društveno odgovorno poslovanje.

Diplomirao je na Pravnom fakultetu u Beogradu, a tokom cele karijere nastavio je da usavršava svoje znanje na prestižnim inostranim institucijama i bankama.

He continues his career at KfW, in Frankfurt on the Development Bank project, then continues on to Vojvođanska Banka in 2012 as Head of the Business and Retail Support Sector and later as Head of the Legal Affairs Sector. He moves to AIK Bank from his appointment as member of the Executive Board, competent for the management of non-performing loans, legal transactions and corporate social responsibility.

He obtained a degree from the Faculty of Law in Belgrade and continues his professional development throughout his career at prestigious international institutions and banks.
